- a) Greenhaugh traffic calming/Burnmouth Bridge: County Cllr J Riddle and Clerk had reported urgent repair to County Council, and Clerk to re report to NCC. On a positive note, Sunday site road had received extensive maintenance works. Ditching at Redheugh would be welcomed, with problems caused by vehicles involved with electricity upgrades. Redmire Bridge to be closed for seven days due to County Council scheme relating to arch refurbishments within the county, and it was agreed diversion would not be too problematic Clerk to confirm agreement with NCC.
