# 2019/58 Highway Matters

## 2019/58/01 Speeding vehicles at school

Clerk had contacted Greenhaugh school and received reply stating they had also been made aware of the problem which saddens them greatly and had already passed on the message to parents in a newsletter, and are reiterating again it is a very serious road safety issue. They had given assurances they would continue to reinforce the message and speak personally to anyone who does not drive with due care and attention to their speed.

## 2019/58/02 Local Transport Plan Programme 2020-2021: Request for visibility improvements

Parish Council proposals from last year, being improvements to visibility at Greenhaugh Bank, and passing places, Redheugh to Greenhaugh had not been included in LTP 2019-2020. Request for resurfacing of footpath to Greenhaugh school had been recorded, would be considered when developing future planned maintenance programmes, and would continue to be monitored. It was agreed to retain the footpath to school, to request passing places between Diamond Cottage to Trough End to accommodate timber wagons, and the removal of passing places Redheugh to Greenhaugh. Third request to be debated and confirmed at September meeting.
