"In 2020 BT were appointed by Ofcom to deliver the Universal Service Obligation (USO) scheme - a piece of government legislation that gives eligible UK addresses the right to request a 'decent' broadband connection. Further details can be found at: https://www.bt.com/broadband/USO. They are in the process of installing Ultra Fast broadband as far as the Comb.

Separately the Government backed Project Gigabit scheme (https://www.gov.uk/guidance/project-gigabit-uk-gigabit-programme) had awarded Go Fibre a contract to provide fibre broadband to premises in North Northumberland, although there doesn't appear to be any details of the properties which may be covered.

2022/88 Highway Matters

2022/88/01 Drainage issues between Lanehead and High Green Maintenance issues remain outstanding. Clerk to re-contact County Council.

2022/88/02 To consider replacement road signs at Greenhaugh and review of all parish road signage Resident comments regarding road signage in the parish had been received as follows:

- 1. Signage opposite West Burnbank for Black Middens Bastle and The Comb could these be moved to the opposite side of the road, or the hedging cut back so that the signs are visible. Many of the guests coming to the Comb miss the signs entirely as they are very hard to see.
- 2. Lanehead road junction the signage there is confusing for drivers, signage falls over and gets overgrown. It detracts from the view and atmosphere at that point, as well as the attention of drivers. Some of the signs are for business that should be easy enough to find without a handmade sign. For others, a totem pole would be easier to read.
- 3. Could Hill house and Old hall gate be added to signage at end of unnamed road at Lanehead.
- 4.Request for "Access only" signage in single track road leading from gatehouse to the Comb as there are no designated passing places beyond gleedlee. Older road signs could do with a wash as they are green and faded.

Parish Cllr D Capps had forwarded evidence of cluttered dirty and unclear signage; overgrown hedging obscuring signs and suggestion for "no through" signage leading to Thorneyburn as there is a locked Forestry Commission gate and the impression the road leads to Kielder.

It was resolved to forward photographic evidence and suggestions to County Council.

2022/90 Northumberland County Council - Notice of Consultation to extend the duration of a Public Spaces Protection Order for the control of dogs

Northumberland County Council were consulting on the proposal to extend the duration of their Public Spaces Protection Order for the control of dogs, Anti-social Behaviour, Crime and Policing Act 2014, Part 4. They believe the PSPS should be extended for a further three years until 30/1/26 and it was resolved the Parish Council had no objection to these proposals.
