- 19NP0071: Brownknowe Field, Greenhaugh – Approval of details reserved by conditions no 4 (construction environmental management plan), 5 (construction method statement), 6 (tree planting scheme) and 7 (track seeding scheme of 18NP0006 – Installation of 25m high lattice mast accommodation 3 No antennas and 2 No 600mm transmission dishes and associated ground based equipment. Installation of 3m wide 100m long track from existing gated access to site and creation of 50m wide area of planting to three sides of compound.


